SHOW TIMES: SATURDAY, MARCH 6th (9AM-6PM) SUNDAY, MARCH 7th (9AM-4PM)

LOCATION: The Ruby Community Center at MYLAN PARK (Morgantown, WV) (Take 1-79 toward Morgantown. Take Exit 155. If traveling Northbound on I-79, turn left off the exit ramp. If you are traveling Southbound, turn right off the exit ramp. Go about a mile and a half. Mylan Park is on the right. (Big white and green building in the lower field).

SET-UP: FRIDAY, March 5th (8AM - 8PM). **LARGE DISPLAYS & EQUIPMENT will have designated move-in times on Wednesday & Thursday. If additional time is necessary, please contact WVRC Media. For Equipment and LARGE displays move in is on Wednesday or Thursday of the week of the show. Please contact WVRC Media at 304-296-0029 if you have any questions about your move-in time.

TEAR-DOWN: All displays and equipment must be removed immediately following the show on Sunday 4-6pm! The building must be vacant Sunday evening after the show! Large equipment moves out Monday by noon. **Please no carts or dollies on the floor until 4pm after attendees have left. Opening and Closing of Bay Doors are to be done ONLY by Mylan Park or WVRC Media Staff ever—no exceptions.**

BOOTHS: Includes blue back draping, 8 foot table (covered), one chair, a table sign and a listing in Event Program.

To secure the best booth location, send us your application and payment as soon as possible.

COURTESY HOLD: When you verbally commit to a booth, please email or fax application immediately. NO BOOTH SPACE will be held without signed contract! This is to ensure fairness to all other vendors reserving the best locations at that time. Your payment must arrive within 7 days.

LIABILITY INSURANCE IS REQUIRED FOR ALL VENDORS: Please email copy of your "Certificate of Insurance" to wvoutdoorsportsshow@wvradio.com prior to February 1st listing "WVRC Media" AS ADDITIONAL INSURED for your participation in this event. If you do not have insurance, Vendor Event Insurance can be purchased online. Call WVRC Media for more information.

HOST HOTEL: WE have a special rate for Vendors at OUR HOST HOTEL(S). The hotel info will be listed in your confirmation letter. The room block(s) will sell out, so book early.

FOOD PERMIT: If you are serving food or samples, You MUST have a Health Permit. Please contact the Monongalia County Health Department at 304-598-5131 by February 15th. They do come to the show to check.

ELECTRICITY: ELECTRICITY IS NOT INCLUDED. To order electricity for \$40, please mark application or contact WVRC MEDIA to add to an existing application. It must be ordered by February 1ST. Not all booths will have access to electricity! To order additional tables (\$20 - covered), or chairs, please mark the application or contact WVRC MEDIA to add to an existing application in advance. You may also bring your own additional tables, chairs, etc.

FREE PARKING: Parking is available to all vendors. VENDOR Parking is in a designated area and must be used during show hours. Please move your vehicles from the unloading areas as soon as you are done unloading. No Vendors are permitted to park in front of the building. **Handicap spaces are available to those Vendors with the appropriate handicap placard.** Thank you for your cooperation!

VENDOR REGISTRATION: Vendors must register upon arrival at the table inside ENTRANCE B. You will then be directed to your booth location and your move-in entrance. Name badges will be distributed on Saturday and should be worn at all times. Vendors must have name badges to exit and reenter the building. YOU must use your designated MOVE-IN entrance to ensure a smooth arrival for ALL VENDORS!

GUNS & EQUIPMENT: All guns must have locks and keys MUST BE REMOVED from ALL EQUIPMENT.

ADVERTISING: The Show is owned by WVRC MEDIA and will be advertised on 60 radio stations broadcasting in WV, MD, OH & PA, as well as digital and social media campaigns, street signs and fliers throughout the region.

A WVRC MEDIA EVENT--POLICIES AND PROCEDURES

1. APPLICATION DEADLINE: Booths are assigned on a first-come / first-served basis. The Show committee reserves the right to make final decisions regarding booth lay-out and positioning as they deem necessary. \$150 Deposit or full payments will be accepted up through 12/1/2026 on the contract. After 12/1/26 all booths must be paid in full.

All new applications after February 1st must include full payment for the booth via Credit Card. NO PERSONAL CHECKS WILL BE ACCEPTED AFTER FEBRUARY 1.

2. LIABILITY: The WV Fishing, Hunting & Outdoor Sports Show, WVRC Media and their management are not responsible for the safety of the property of exhibitors due to theft, damage by fire, accident, vandalism, or other causes. The exhibitor agrees that it will indemnify and hold and save The WV Fishing, Hunting & Outdoor Sports Show, its directors, WVRC Media and its subcontractors harmless against all claims, demands, actions, damages, loss, cost, liability and judgments against WV Fishing, Hunting & Outdoor Sports Show on account of any injury or damage to persons or property associated with this event. Exhibitor covenants and agrees that should the WV Fishing, Hunting & Outdoor Sports Show or WVRC Media be made a part of any litigation commenced by or against Exhibitor or relating to this show, the exhibitor shall and will pay any costs and expenses, including reasonable attorney's fees and court costs, incurred by or imposed upon the WV Fishing, Hunting & Outdoor Sports Show or WVRC Media by virtue of any such litigation.

3. APPLICATION: WVRC Media reserves the right to reject ANY application for any reason, at any time.

4. CANCELLATION POLICY: Booths cancelled prior to November 1, 2026 will receive a full refund minus a \$150 administration fee. No refunds will be given after November 1st. In the event the show is cancelled due to circumstances beyond the control of show management (severe weather, building damage, emergencies, Covid resurgence, etc.), the show will be rescheduled immediately and NO refunds will be given. WVRC Media will assume responsibility for the expense of the additional advertising of the new date only, etc. All other expenses will be the responsibility of the vendor. Should severe weather force the show to close early, there will be NO REFUNDS. Deposits of \$150 prior to 12/31/26 are non-refundable.

5. NON-TRANSFERABLE: Exhibitor space contracted may not be shared or transferred to another party without the written permission of WVRC Media.

6. INSURANCES & PERMITS: Liability insurance is required for all vendors. No food or drinks may be distributed without Product Liability Insurance and the proper Health Department permits. Contact the Monongalia County Health Department (304) 598-5131. Please email copies of insurance and permits to wvoutdoorshow@wvradio.com

7. EXCLUSIVITY: The Show does not guarantee any vendor the exclusive right to sell any product or service.

8. SALES TAX: Exhibitors are responsible for collecting and paying all applicable sales taxes, permit fees and having proper licensing.

9. FURNITURE RENTAL: You may bring additional tables and displays or additional tables and chairs may be rented. Please contact WVRC Media for prices and availability. **NO SPACE OR FLOOR HEATERS, HELIUM or PROPANE TANKS or BALLOONS ARE PERMITTED IN THE BUILDINGS.**

10. PROPERTY DAMAGE: No vendor may damage, injure or deface the turf, floor, track, any furniture, fixtures, equipment or any part of the exhibit facility. Nails, screws, staples, pins etc., may not be driven into any property including furniture, draping, fixtures, equipment or the building. The rubber floor must be protected at all times. Equipment must be placed on cardboard or plywood. Oil pans should be under vehicles. All vendors will be held responsible for payment of any damages done by himself, employees or agents associated with his booth to the owner of the property.

11. EXHIBITS: Vendor agrees to exhibit only those products listed on the application and approved by WVRC Media.

12. RETURNED CHECK POLICY: Vendors will be charged a \$35 administrative fee for a returned check. A valid check or Credit Card must replace that check within 5 days.

13. MEDIA RELEASE: As a vendor, you release to WVRC MEDIA your photographic, television and all other similar rights to be used for advertising and promoting the event.

The WV Fishing, Hunting & Outdoor Sports Show reserves the right to make any change, anytime as necessary and shall have full power to interpret amend and enforce these policies and procedures, provided any amendments, when made, are brought to the notice of the exhibitor. Each exhibitor, for himself and his employees, agrees to abide by the foregoing policies and procedures and by any amendments as added.
